EXECUTIVE SUMMARY

Select Board Members: The purpose of this summary presented is to give you some information over and above just the mentioning of the subject matter on the agenda. It is my hope that this information assists you in your decision making.

MANAGERS REPORT

- -Playground Update: Prepping the area is presently underway. Weather has delayed some efforts but once completed it will be ready for set up of equipment in the Spring.
- **-Mack Truck Update:** Roger has visited the vendors location again and received an e-mail indicating that the Frame Rails are replaced, the unit is inside having the Engine & Transmission installed and the Cab will be placed on the unit shortly.
- **-Fire Station Roof:** At this writing the Roof is to be completed on Saturday & Sunday (12-10 & 12-11). Will try to have photographs of the work for your meeting.
- **-Eastern Trail Fence Work:** Eastern Trail received a grant for some fence work on the Trail in Arundel. Areas have been identified off of Hidden Meadows Drive. The Town will provide the remainder of our Eastern Trail Maintenance Budget to supplement the cost to purchase and install the fence and will work with the Gas Company and Vendors to complete the project.
- **-GIS Arundel:** The Geographic Information System has been completed and installed on the Town Website. This technology allows folks to view properties and provide layers to indentify Set Back, Zones, Wet Lands, abutters list etc..

- -Escrow Account for Performance Assurance: Board reviewed the new Performance Assurance indicating Biddeford Savings holding an escrow for the road work on Route #1 for the Arundel Cottages Project. Board had not objections with the Manager signing the approved adjustments reviewed by all Attorneys for action.
- -Crosswalk Route #1 Manager met with one of the Food Truck vendors. The Food Truck owners have agreed to purchase the pedestrian signals to be placed so we are in compliance with the approved plan. Manager will coordinate the purchase and placement.

Business

-Proposal for Fire Station Roof Repair: MOTION Nedeau second Hayes to accept the alternative proposal from Robert Zuke Builders, LLC of Arundel Maine for a proposal not to exceed \$42,000" passed 5-0. Two other contractors

were requested to provide alternative pricing. They were Williams Construction Company of Brewer Maine @ \$39,130.00 and AM Construction of Caribou Maine @ \$42,750.00.

<u>-General Ledger Statement</u>: Selectmen Hayes provided some details as to what her expectations on the report were and had spoken to the Deputy Treasurer.

<u>-TIF Capture Cost Committee:</u> Some members of the Budget Board would like to get involved with this Committee. Manager now has seven folks of the community indicating there interest. They are Michael Thomas, Joe Simard, Chip Bassett, Jack Reetz, John Bell, Michelle Allen, Jack Turcotte. Board felt this group along with their involvement was enough and will coordinate a meeting to be held sometime the first of the new year.

<u>Payable Warrant & Payroll:</u> MOTION Hayes second Labbe "approve warrants as presented and reviewed" passed 5-0.

Further Business: Board wanted to know the status of 159 Proctor Road.
